5. Report on FACT Activities

Please find below the Chair's report:

2022-23 has been a complex year.

The unexpected resignation of our last Chair did cause a short term hiatus. However after discussions with HIE we were found to be a reasonably sound organisation. However like many other charities it has been a difficult balance between the funding we get, and the services we provide.

The Board of Directors would like to express our appreciation to our Funders.

The local ones like Berry Burn Community Trust, Auchernack Trust, Beatrice Community Fund, TSI Moray and Moray Local Area Fund.

The national ones, National Lottery Community Fund, Historic Environment Scotland, AHF, DTAS, Crerar Trust and the Community Ownership Fund.

Highland and Islands Enterprise have provided and continue to give us unrivalled support in the day-to-day operation of FACT.

Let's not forget the local residents and local companies who have made notable donations, and of course all the bawbees dropped into the collection tins. We are very grateful to local shops for donations to the weekly Coffee Mornings and special thanks to TESCO and the CO-OP for their support of our Pantry.

The Board have, throughout this year have been updating our Policies and Procedures. These are our Governance documents, which ensure we comply with the various legislations that apply to or affect FACT.

We have continued with our plans for refurbishment of the Town Hall.

However rampant inflation and subsequent price rises have forced us to phase the project. The Refurbishment Team meet regularly and continue to try and push things forward. We hope to achieve a major step shortly and arrange for the repairs to the roof and the installation of insulation to the roof area. This alone is expected to have a positive effect on the running costs of the building.

The team would like to say how much we appreciate LDN Architects for answering our seemingly unending questions.

The Board and Management will continue to work to make the Town Hall a welcoming place, and an improving asset for the Community.

The Board recently agreed to look at raising monies to pay our Core Costs. These are things like electricity, our FACT employee's wages, the incidental things that every household has to purchase.

The ambition is to make FACT self-financing. We hope to set up small group of volunteers and supporters to collect ideas and to implement the best of them. So please, if you are

interested in being part of this group, please contact any member of the Board, or Nick Clark (Operations Manager) or a member of staff. We can also be contacted through email or website and Facebook. There have been some very interesting ideas put forward already.

You may have noticed the poster as you came in, or the press release in the Forres Gazette that we are looking for FACT members to join the Board of Directors.

The work is not onerous, it is a commitment to attend Board Meetings to read various documents, to discuss them, to voice your opinions and to exercise your skills. If you join a subcommittee or become an Office Bearer, yes it's a bigger ask, but no one has to do more than the initial commitment, unless they wish to.

I can tell you, it's very rewarding, being part of this venture. We are very proud of what has been achieved over the years.

It is the Board who will make the decisions, taking FACT forward into the future, and continuing the sterling work that FACT does every day in the Community.
